iv. **Tree Damage to Well #3 Roof and Loss of Well #7 Pump –** Recent wind event brought down tree on roof, necessitating repair of the trusses, roof deck, and shingles. Pump at Well #7 failed due to motor short. Due to age of pump, pump being replaced as well as new motor provided. While pump was pulled, Kohl Bros. performed video inspection of casing at Well #7.

Discussion: Becker stated need for Project on Well #7 many issues: install VFD's on pumps, add corrosion control, replace nitrate removal system, waste

pump, building modification. Becker suggested a board member visit on site to better understand issues.

Consensus was to move on the project as it is a high priority level, starting with a proposal on preliminary design.

- **b. Operations Manager's Report:** Bock presented his monthly report to the Board. Spring flushing of the water lines will begin May 7th through May 26th.
- c. Engineer's Report: Zawrotuk stated about the Water Main Replacement Project: As of Fri 4/28/23 waiting on data survey information from Honor, who completed the field work. NPDES Permit Renewal: working to get applications completed.
